PrimeSafe is the governing body for regulating the safety of meat, poultry and seafood in Victoria. Food Safety Programs and Audits are compulsory for meat retailers in Victoria to ensure whether an effective Food Safety Program has been implemented. It must be conducted by an approved food safety auditor.

Where you are cooking on the premises and/or packaging ready-to-eat products the required audit scope is higher - so it costs more to deliver. AMIC can help you implement a suitable Food Safety Program and Audits. Talk to AMIC about your needs.
