A Food Safety Program is a written plan that shows how each business is managing food safety. *SafeFood Queensland* requires that Food Safety Programs are implemented in all primary industries that have an identified food safety hazard. The AMIC Food Safety Program is created after the business has systematically examined its own particular operations in order to identify the hazards.

The Food Safety Program Manual will help you specify how:

- identified hazards are to be monitored and controlled
- hygienic and safe handling conditions are monitored and maintained

A Food Safety Program is compulsory for meat retailers. AMIC can help coordinate and implement your Food Safety Program.
